All members are encouraged to submit anything which has not been in previous All Members' shows.

Who is eligible? Any current member of the CCC; every age, every level.

What is eligible? Broadsides only, no 3D items. There are no size constraints.

Are there any fees? There is no entry fee and Holmstad will not take any commission on our sales.

Is there a per person limit? Yes, each member may submit up to four pieces.

How do I prepare my piece for hanging?

1. Use a wire for hanging
2. Attach a completed and signed entry form to the wire
3. Fill out the title plate forms on page 2 and include them-unattached-with your pieces.

Deadline for registering is January 15, 2024
